

Making Important Choices for the Future



One hundred years ago, during the winter of 1914-15, the Board of Directors of our Lakewood Masonic Temple Company was busy trying to wrap up important design choices for the new Lakewood Masonic Temple and raising the necessary funds to advance the evolving design from the architectural drawing phase to the construction phase. [Our current Board of Trustees might rightly note that, a century later, it seems that some things never change.]

In April 1914 the Temple Company's stockholders had agreed to raise the \$20,000 capital stock in the corporation to \$75,000, reflecting the evolving higher cost estimates for the new Temple. That spring floor plans were circulated and changes made to accommodate suggestions from the various constituent organizations that would meet in

the new Temple. [Lakewood Lodge F&AM, Lincoln Chapter OES, and Cunningham Chapter RAM pre-dated the 1912 incorporation of the Lakewood Masonic Temple Company; and in 1914 Gaston G. Allen Lodge F&AM was in the process of formation to accommodate the surge in new members that Lakewood Lodge was unable to handle.]

By July 1914 the cost estimates added up to \$83,000 to which \$4,000 would have to be added for an all-stone exterior [which was eventually decided in March 1915] plus additional amounts for interior decorations and fixtures.

An agreement with Lakewood State Bank was reached in September 1914 to borrow \$5,000 to \$10,000 on short notice if required.

In December 1914 the Building Committee wanted to request an exception from the Ohio State Building Code which required fireproof window frames and sash on the west façade of the building. The Committee subsequently modified its recommendation to include plans for metal window frames on the second floor, basement and mezzanine floors. [As the Temple was eventually built,

Appreciated Assets As One-Time Gifts

With stock markets once again surpassing their all-time highs, the opportunity to make gifts in the form of appreciated assets becomes more attractive to many donors.

There are various reasons to use appreciated assets to make one-time gifts to an organization such as The Lakewood Masonic Foundation. Chief among them are the sense of personal satisfaction you will achieve from making a special gift and the likely benefit you will receive from the unique tax breaks for this type of gift.

A gift of an appreciated asset often provides you with a greater tax benefit than a gift of cash. For example, a gift of appreciated stock that you have held for more than 12 months can be deducted at its current value if you itemize deductions, and you won't have to pay capital gains tax on the appreciated portion of your gift. As always, you are encouraged to consult with your legal and tax advisors before making a gift of this type.

There are two ways to use appreciated assets—such as stocks, bonds, mutual fund shares, real estate and insurance policies—to make a special gift. One option is to donate the asset outright, meaning that it would be transferred immediately from you to The Lakewood Masonic Foundation. Another option is to fund a lifetime income gift, which will provide you with income for your lifetime or for some other specified period of time.

If you prefer to make a more straightforward gift, you may simply write a check using the form in our newsletter (see page 11), by responding to our semi-annual letter appeals or by adding a donation to your annual dues.

You may designate your gift or bequest to be used for our historic preservation, educational or charitable purposes; split your gift among these purposes; or simply ask that your gift be devoted to our greatest need. All gifts, other than a small percentage spent for printing and mailing, are used for our stated purposes.

Your donation is a special way of showing your love for our Lakewood Masonic Family and for our historic home. Our 2016 Centennial is fast approaching, and we still have lots of catch-up maintenance to complete on our facilities.

While gifts and bequests may be directed to our Lakewood Masonic Foundation, our Lakewood Masonic Temple Endowment Fund or our Lakewood Masonic Temple Company Operating Fund, please note that only gifts and bequests to our Lakewood Masonic Foundation are deductible for federal income and estate taxes to the extent permitted by law. Gifts to our Endowment and Operating Funds are not deductible; but, depending on your tax situation, deductibility may not be an issue for you.

High Priest's Message

Companions:

I have found myself a couple months into my first voyage of what it feels like to be in the East. I must say, although these tasks can be sometimes difficult and, not to lie, stressful, I am becoming more of a heartdriven individual than I thought I could ever be. And I hope that each and every Mason throughout his journey feels the sense of transformation that I feel in this fraternity. Through every step, every lecture, every lesson, the heart grows fonder. As the heart grows fonder, the mind ceases to obtain an ego. By ego I mean the conscience of the mind to your own self, and I hope through Masonic teaching it withers away. For yourself is not of importance, it is those around you who make your perception of life the reality of what it truly is. These are the strong points of our Chapter. What you give, give freely; For the Lord loveth a cheerful giver. Even if what you give is your time, your efforts, your feelings, your contributions, or even your sacrifice, you are giving another human being the power of truth; or at least leading these unfamiliar minds to a path of their own truth. We conferred the degree of Mark Master last month; and, although it was a little rocky, I believe we impressed upon the mind of our candidate the true observation of that degree. He is very curious and ambitious to proceed in his Masonic knowledge for the rest of my time in the East, and I plan to fulfill that request. Our Inspection this year will be in the degree of Royal Arch in February. I have every intention to practice this fully and sufficiently to execute an amazing degree. Once again, I cannot do it without the support and love of my Companions; and I treasure and appreciate each and every one of you. Let us prepare the minds for Inspection. There may be a degree or two along the way, but I anticipate February to be a very rewarding month for all of us. Give what you can, when you can, and be cheerful to do so.

steel frame & sash tilt windows were installed on all four façades on the Banquet Room, Lodge Room and Lodge Balcony levels. The triple hung windows installed on the Ballroom and Mezzanine levels were (and are) metal on the west façade and wood on the south, east, and north façades.]

A century later we are engaged in the process of choosing how to handle our aging windows. They are a distinctive feature of our historic fraternal home and must either be restored or replaced with historically appropriate modern windows. The historic window restoration process is challenging and expensive in its own right, and it would leave us with 1916 technology windows lacking the energy efficiency of modern windows; so we would have to incur the additional expense of either exterior or interior storm windows. And we don't get to make this choice on our own. By virtue of being located in Downtown Lakewood, the City must agree to any changes in our exterior appearance. Several years ago we reached an agreement with the City and replaced our Lodge Balcony level windows with historically appropriate modern windows. But either way, we will depend on *your* important choices—will *you* share some of *your* treasure, large or small, with our Lakewood Masonic Family to fund these vitally necessary upgrades?
