English Emulation Ritual in Lakewood

Goose and Gridiron Lodge No. 1717, a special interest Lodge chartered by the Grand Lodge of Ohio, will meet at our Lakewood Masonic Temple on Saturday, March 5, for its Annual Meeting and Installation of its new Worshipful Master. Lodge will open at 12:00n and will be followed by a traditional Festive Board.

All recognized Masons are welcome to attend but must register in advance on the Goose and Gridiron Lodge Wild Apricot web site and agree to adhere to the Lodge's strict dress code.

Goose and Gridiron Lodge takes its name from the Goose and Gridiron Tavern at which several English Lodges met to form the first Grand Lodge of England in the year 1717, from which the Lodge takes its number.

Goose and Gridiron Lodge is authorized by the Grand Lodge of Ohio to use the Emulation Ritual of the United Grand Lodge of England (UGLE), to which most American Lodges ultimately trace their roots. Pursuant to its establishment two centuries ago with the amalgamation of the Ancients' Moderns' Grand Lodges, UGLE adopted the standard but non-exclusive Emulation Ritual for use by its Craft Lodges (see the articles on page 10).

By English custom, Goose and Gridiron Lodge will open in the First Degree and progress through the Degrees to a Board of Installed Masters in which the new Master will be installed by other Installed Masters. After closing the Board, the Lodge will revert through the ceremonies of the Third and Second Degrees and resume in the First Degree to

invest its other officers and conduct its regular business. This means that Entered Apprentice and Fellowcraft Masons will be able to witness significant portions of the Emulation Ritual ceremonies. Also by English custom, a collection will be taken for Charity.

Our historic Lakewood Masonic Temple is honored to host this year's Grand Master's One Day Class on Saturday, March 26. Our Temple's impressive architecture and decoration and the size of our facilities make it an especially appropriate venue for such an event. Facebook users may donate through our Facebook page. Facebook does not charge a fee to our Lakewood Masonic Foundation or other not-for-profit organizations.



Holders of traditional (not Roth) IRAs must begin taking required minimum distributions (RMDs) in the year they turn age 70-1/2. Distributions made directly from an IRA to a qualified charity such as our Lakewood Masonic Foundation can count toward your required minimum distribution, subject to a collective limit of \$100,000 per year. Such distributions do not incur either federal income or estate taxes but also do not count as itemized deductions for tax purposes.



Donations can be made after death by naming The Lakewood Masonic Foundation as a beneficiary in your will, life insurance policy, IRA, TOD (Transfer on Death) account or the like, either as a fixed amount or a percentage. A will can be amended by codicils without having to be rewritten in its entirety. In matters such as these, you are best advised to discuss your intentions with an attorney and/or tax accountant.



Gifts may be in the form of cash, securities or property. Gifts of appreciated securities and/or charitable gift annuities can be especially beneficial to the donor. In matters such as these, you are best advised to discuss your intentions with an attorney and/or tax accountant.

Some employers have payroll deduction plans and/or matching gift programs for charitable giving. Check yours.

Gifts and bequests to our Lakewood Masonic Foundation (but not our Lakewood Masonic Temple Endowment Fund or our Lakewood Masonic Temple Company Operating Fund) are deductible for federal estate and income taxes to the extent permitted by law. As always, we encourage you to consult your legal and financial advisors for assistance in determining in what form and in what amount you should make any major gift or bequest.

Prentice Pillar

In the southeast part of the Chapel of Roslyn Castle, in Scotland, is the celebrated column which goes by this name, and with which a Masonic legend is connected. The pillar is a plain fluted shaft, having a floral garland twined around it, all carved out of the solid stone. The legend is, that when the plans of the chapel were sent from Rome, the master builder did not



clearly understand about this pillar, or, as another account states, had lost this particular portion of the plans, and, in consequence, had to go to Rome for further instructions or to procure a fresh copy. During his absence, a clever apprentice, the only son of a widow, either from memory or from his own invention, carved and completed the beautiful pillar. When the master returned and found the work completed, furious with jealous rage, he killed the apprentice, by striking him a frightful blow on the forehead with a heavy setting maul. In testimony of the truth of the legend, the visitor is shown three heads

in the west part of the chapel—the master's, the apprentice's, and the widow's. There can be but little doubt that this legend referred to that of the Third Degree, which is thus shown to have existed, at least substantially, at that early period.

It is proposed to amend Section 7 which currently reads:

The Annual dues shall be Forty dollars (\$40.00), payable on or before the first day of June. If such dues are not paid on or before June 30, notice shall be given at once by mail to each member who has not paid his dues. Failure to receive notice shall not excuse the non-payment of dues. (Sec. 110.03 of Code. May not be less than \$5.00. Sec.110.02 of Code.)

If the fee is paid in full, or if the Mark Master fee is on deposit, with unanimous consent, a single ballot for all the degrees may be had, but under no circumstances may a degree be conferred until the fee therefor is paid. The fee for membership by affiliation shall be Forty Dollars (\$40.00).

so that the same shall read:

The fees for the degrees in this chapter shall be Fifty Dollars (\$50.00) plus the current Grand Chapter assessment payable in full when the petition is presented, or, by unanimous consent of the chapter, divided as follows: Mark Master Degree Twenty Dollars (\$20.00) plus the current Grand Chapter assessment; Past Master Degree, no charge; Most Excellent Master Degree Fifteen Dollars (\$15.00); Royal Arch Degree Fifteen Dollars (\$15.00). If the fee is paid in full, or if the Mark Master fee is on deposit, with unanimous consent, a single ballot for all the degrees may be had, but under no circumstances may a degree be conferred until the fee therefor is paid. The fee for membership by affiliation shall be Fifty Dollars (\$50.00) plus the current Grand Chapter assessment.

Commander's Message

Sir Knights:

Help needed! We will confer the Order of the Temple at our March 3 stated conclave and for our March 19 Inspection. We need you!

Also, to cope with rising costs, we, along with our fellow Lakewood York Rite bodies Cunningham Chapter and Lakewood Council have been considering how to adjust our collective dues structure. At our February stated conclave **two proposed amendments to our bylaws were submitted and will lay over to our March stated conclave:**

It is proposed to amend Article 3 which currently reads:

Fees: The Fees shall be: For the orders, \$130.00 dollars, and for membership by affiliation, \$130.00 dollars.

so that the same shall read:

*Fees: The Fees shall be: For the orders, **\$90.00 dollars plus the current Grand Commandery and Grand Encampment assessments**, and for membership by affiliation, **\$90.00 dollars plus the current Grand Commandery and Grand Encampment assessments.***

It is proposed to amend Article 4 which currently reads:

Dues: (a) The annual dues of each member shall be \$130.00 dollars, which includes (\$1.00) one dollar for the Knights Templar Eye Foundation (except those who are Life Sponsors, Patrons or Associate Patrons) and shall be payable on or before May 31st of each year.

so that the same shall read:

*Dues: ~~(a)~~ The annual dues of each member shall be **\$90.00 dollars plus the current Grand Commandery and Grand Encampment assessments**, ~~which includes (\$1.00) one dollar for the Knights Templar Eye Foundation (except those who are Life Sponsors, Patrons or Associate Patrons)~~ and shall be payable on or before May 31st of each year.*

With regard to the Eye Foundation, Grand Commandery adopted a new fee structure by which each new member is assessed a \$30.00 Eye Foundation fee in addition to his petition fee, thus making him a Life Sponsor and eliminating the one dollar annual assessment. The annual Grand Commandery and Grand Encampment assessments are \$10.00 and \$9.00.



Hour-Glass



An emblem connected with the Third Degree, according to the Webb lectures, to remind us by the quick passage of its sands of the transitory nature of human life. As a Masonic symbol it is of comparatively modern date, but the use of the *hour-glass* as an emblem of the passage of time is older than our oldest known rituals. Thus, in a speech before Parliament, in 1627, it is said: "We may dandle and play with the hour-glass that is in our power, but the hour will not stay for us; and an opportunity once lost cannot be regained." We are told in *Notes and Queries* (First Series, v, page 223) that in the early part of the eighteenth century it was a custom to inter an hour-glass with the dead, as an emblem of the sand of life being run out.

There is in Sir John Soane's Museum, Lincoln's Inn Fields, London, a manuscript account book, of 1614-41, once owned by Nicholas Stone, Mason to King James I and Charles I, which on the title page has the following written note:

*In time take time while time doth last,
For time is no time when time is past.*

A few sad and studious lines written in his Bible by Sir Walter Raleigh are found in Cayley's biography of him (volume ii, chapter ix):

*E'en such is time! which takes in trust
Our youth, our joys, and all we have;
And pays us naught but age and dust,
Which, in the dark and silent grave,
When we have wandered all our ways,
Shuts up the story of our days.
And from which grave, and earth, and dust,
The Lord will raise me up, I trust.*

Longfellow, in his "Sand of the Desert in an Hour-glass," has written thus:

*A handful of red sand from the hot clime
Of Arab deserts brought,
Within the glass becomes the spy of Time,
The minister of Thought.*

An hour-glass is in the possession of the Lodge at Alexandria, Virginia, of which our Brother George Washington was Master. That old treasure, a measure of the flying moments, well exhibits the changing methods brought about in time.

Emulation Lodge of Improvement

At the time of the Union of the English Lodges in 1813, a Lodge of Reconciliation was constituted with an equal number of chosen workers from each Constitution for the purpose of arranging a uniformity in the Making, Passing, and Raising of Freemasons in all of England. After this was done, the ritual and ceremonies established, the Lodge was dissolved in 1816, having received the authority and sanction of the United Grand Lodge. For making these known to the Craft generally a system of Lodges of Instruction was set up and Past Masters who were qualified went from Lodge to Lodge as teachers or Preceptors as they were later called. The most eminent and earliest of these was *Peter Gilkes* (which see). As a continuation of the work of the Lodge of Reconciliation the Emulation Lodge of Improvement for Master Freemasons was formed for instruction in 1823 with government entrusted to a Committee of Lecturers. The Committee is elected annually by the working members of the Lodge, the senior member acting as leader. About 1830 the Lectures began to give place to rehearsal of ceremonies. Minute Books prior to 1859 were destroyed by fire. Therefore such records as are available are from pages of the *Freemasons' Quarterly Review*, the *Public Ledger* and the Minutes of various Lodges with which Peter Gilkes was associated. The celebration of the Centenary of this school of Masonic ritualism was held in the Grand Temple at Freemasons Hall in Great Queen Street, London, on March 2, 1923, presided over by the Pro Grand Master, the Right Honorable Lord Ampthill. No English Lodge is compelled to conform to Emulation working and there are Lodges working independently, but for over a hundred years the ritual and ceremonies as taught by the Emulation Lodge of Improvement have been the standard recognized method. We are indebted to Brother George Rankin, Senior Member of Committee of Lecturers, London, for the above details (see also *Illustrated History of the Emulation Lodge of Improvement*, Henry Sadler, London, 1904).

Emulation Today

It would be idle to pretend that Emulation is today anything like the force it was in former times. The late Bro. Colin Dyer, in his history already referred to, expressed the view in 1973 that the use of detailed books of ritual seemed to have taken the place temporarily of the comradeship of the Lodge of Instruction, but hoped that falling numbers might prove to be a passing phase. That assessment how appears to have been unduly optimistic. Lodges of Instruction generally are in serious decline, and Emulation with them. This is the result of social and other pressures which in recent years have militated against regular weekly attendance, and there is no sign at present of those pressures abating. Nevertheless, Emulation still teaches and maintains the highest standards of Masonic ritual


